ASSIGNMENT OF OIL AND GAS LEASE.

THIS AGREEMENT, Made and entered into this 18, day of October 1909, by and between the Olive Oil Company, a corporation organized under the laws of the state of Oklahoma, the party of the first part and F. A. Gillespie party of the second part.

WITNESSETH: WHEREAS, the first party herein, the Olive Oil Company, is owner of an oil and gas lease and leasehold estate, evidenced by a certain indenture of lease executed by Henry C. Martin to the Olive Oil Company, on the 27, day of July 1908, and upon the following described property, to-wit:

East Half of North West Quarter of the North East Quarter, The North Half of the North East Quarter of the North East Quarter, and the South East Quarter of the North East Quarter of the North East Quarter, Section 30 (Thirty ), Township 21 (Twenty One ), Range 13 (Thirteen. The South West Quarter of the South West Quarter of the North East Quarter Section 31 (thirty One), Township 21 (twenty one ) Range 13 (thirteen).

And whereas, the parties hereto have entered into an agreement of transfer of said lease and leasehold interest:

NOW, THEREFORE, for and in consideration of the sum of \$221.00 (Two Hundred Twenty One Dollars) and other good and valuable consideration paid by the party of the second part to the first party herein, receipt and payment whereof is hereby acknowledged, the first party has bargained, sold, transferred, assigned and set over and does by these presents bargain, sell, transfer, assign and set over the above described oil and gas lease and leasehold estate and all it's rights, title and interest in and to the same unto the second party herein, their heirs executors, administrators and assigns.

TO HAVE AND TO HOLD THE SAME, with all the rights, privileges and appurtenances thereunto belonging forever.
