by affidavit of said Thomas B. Scobey, and the Court on said day having made an order directing said return of sale to be heard on this 24th day of January, 1910, and this Court having examined said return and having in open Court also examined said Thomas B. Scobey, and it appearing to the satisfaction of the Court:

That in pursuance of said order of sale said Thomas B. Scobey caused notice to be given of the time and place of holding said sale by posting up three notices in three of the fost public places in said County of Tulsa, State of Oklahoma, in which the lands ordered to be sold are situated, and to be published in the Tulsa World, a weekly newspaper printed and published in said County of Tulsa, State of Oklahoma, two weeks, (three issues) next before the time on or after which said sale was to be made and before which time said sale was made, and proof of posting and publication thereof filed in this Court, in which notice the lands and tenements to be sold were described with common certainty.
