RENTAL CONTRACT.

THIS AGREEMENT, Made and entered into this 27th day of August, 1909, by and between W.E. White of Tulsa County, Oklahoma, party of the first part, and L. M. Davis, party of the second part,

WITNESSETH, that for and in consideration of the covenants and agreements hereinafter made, the party of the first part has let, leased and demised and does by these presents let, lease and demise unto the party of the second part for agricultural purposes, for the term of (Five Years) from and after the (1st day of January 1910) the following described tracts of land lying in Tulsa County, State of Oklahoma:

The southeast (1/4) section (10) township (16) range (12), and the southwest 1/4 of the southwest 1/4 of section (11) township (16) range (12) except his house and lots fenced in adjoining same? about eight acres;

The said party of the second part, for the use of said land, agrees to pay to the party of the first part, as rent per annum during the term of this contract, payable as follows:
