\$250.00 on the 1st day of January 1914.

And the second party further agrees to keep the place in good shape and to work the place in a good workmanlike maner, and to not plant any crops that will be detrimental to said land, or pasture said land while the ground is wet or muddy to take good care of the orchard and not to let any stock run in among the trees and destroy said trees; and keep fence and buildings in as good repair as the same now is or may at any time be placed in by leasor, as when the same were entered upon by the party of the second part, loss by fire or inevitable accident and ordinary weare excepted.
