MEMOLARDER OF AGREEMENT, Made and entered into by and between T.S. Fears party of the first part and J.H.N. Coba, as the Guardian of Billy Atkins and Salina Atkins, incompatents, parties of the second part.

WITHESSETH: That whereas the said Billy Atkins as the sole heir at law of Anderson Atkins, deceased, did on the 4th day of January, 1906, executo a n Agricultural lease to the Rock Island Truse & Investment Co., same being on record and recorded in Book 35 at page 68 for a term of one year from January 1st, 1910, and embracing the following described lands situate in what is now Tulsa County, Oklahora, to-wit:
