the sum of Sixty nine & 80/100 dollrs, (\$69.80) being 25¢ cents per rod, together with all damages which might arise to crops or fences, and any other damage occasioned from the laying, maintaining and operating of said pipe line and telegraph or telephone lines.

That, afterward on the 23rd day of November 1909, said petition was duly considered by suid court, and it was ordered and directed that said Guardian execute to the said The Prairie Oil & Gas Company, a grant of the right of way over above described premises in the nature of an easement upon the terms and conditions of said petition.

Pursuant to the order of said Court, and in consideration of Bixty nine & 80/100 Dollars, the receipt of which is hereby admowledged I, Ed Hart, as Juardian of the estate of the said BLAford W. Miller, minor, do hereby grant to The Prairie Oil & Gas Company, its successors and assigns the right of way in the nature of an easement to lay, maintain and operate a pipe line and tele; raph and telephone line said telegraph and telephone line to be on section lines, for the transportation of grude oil over and across the said premises, with ingress and egress to and from the same; the said party of the first part to fully use and enjoy said precises except for the purposes herein granted, the party of the second part to ay any damages which may arise to crops or fences and any other darages caused by the laying, maintaining, and operating of said pipe line and telegraph or telephone line; said darages if not mutually agreed upon to be ascertained and determined by three (3) disinterested persons-one thereof to be appointed by the Said Grantor, one by the Prairie Cil & Gas Company, it's successors or assigns, and the third by the two so appointed, and the award of such three persons shall be vinal and conclusive. And it is hereby further agreed that the said The Prairie Cil & das Company, its successors or assigns, may at any time lay an additional line of pipe alongside of the first line, as herein provided, upon the payment of a like consideration, and subject to the sume conditions; also to have the right to change the size of its pipes; the damage, if any, in making such change, to be determined and paid by the said The Prairie Oil & Gas Company, as in the mannor as above provided.
