The party of the second part his successors or assigns shall have the right at any time on agment of one dollar to the party of the first part her heirs or assigns, to surrender this lease for cancellation, after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine and this lease become absolutely null and void.

All covenants and agreements herein set forth between the parties hereto shall extend to their successors, executors administrators and assigns.
