AND THAT, the defendants nor either of them have any right, title, interest, equity or estate therein, nor lien nor incumbrance thereon, and that all their claims in and to the said property, be and are forever quieted and each of said defendants are forever barred of all right, title, interest, equity or estate, or lien or incumbrance upon said property, and the right, title, interest, estate and possession of the said plaintiff is forever quieted against any and all claims of said defendants or either of them, and that all the said defendants and each of them are forever enjoined from asserting any right, title, interest, equity or estate or lien or incumbrance on said premises, or any part thereof, and that the plaintiff recover his costs.
