Oil and gas lease.

THIS IND MURE made the 19th day of January 4.D. 1910 between John D. Gray, guardian of Thelma Beatrice Bright a minor of the------of Sapulpa, County of ^Creek, and state of Oklahoma, lessor, and C.R. Howard lessee.

Witnesseth, that the isssor in consideration of Forty two and 50/100 Dollars, the receipt whereof is hereby acknowledged, does hereby grant, demise and let unto the said lessees, all the oil and gas in and under the following described tract of land, with covenant for the lessee 's quiet enjoyment of the term and that lessor has the right to convey the premises to the said lessee, together with the excludive right unto the lessee to operate and drill for petroleum and gas, to lay and maintain pipt lines, to erect and maintain telephone and telegraph lines, and buildings convenient for such operations; and the right to use water and gas from said lands in operating same, and right of way over same for any purpose, and right of ingress, egress and regress, for Much purposes, and of removing either during or at any time after the term her of, any property or improvements placed or erected in or upon said land either during or at any time ofter the torn hereof, any property or improvements placed or crected in or upon said land, by suid lesses, and the right of sub-dividing and releasing all or any part of all that tract of land situated in the Creek Nation and in County or Wagoner and State of Oklahoma bounded and described as follows, to-wit;

The southwest quarter of the Northwest quarter of section nine (9) and the Northeast quarter of the Northeast quarter of the Southeast quarter of theNortheast quarter of section eight (8) all in township sixteen (16) North, Range rourteen (14) east containing forty two and 1/2 acres, more or less.

To have and to hold unto and for the use of lessee for the term of five years from the date hereof and as much longer as gas and oil is produced in paying quantities, yielding to the lessor one eighth of all the oil produced andsaved from the premises, delivered, free of expense into tanks or pipe lines to the lessor's credit.

Should a well be found producing gas only, then the lessor shall be paid for each such gas well at the rate of One Hundred fifty dollars
