Oil and Cas Lease. AGREEMENT, Made and entered into this 20th day of January A.D. 1910 by and between Robert L. Keys and Ollie M. Keys, (his wife) of Tulsa, County, and State of Oklahoma, lessors and J. K. Ronne Lessee.

WITNESSERH; that the lessors in consideration of one dollar the receipt of which is hereby acknowledged, and the covenants and agreements hereinafter contained and to be kept performed by the lessee, does hereby grant unto the lessee his heirs, successors and assigns, all the Oil and Gas in and under the following described tract of land for the sole purpose and with the exclusive right of operating thereon for oil and gas, togeth r with the right-of-way over and across said premises to all places of operation, by said lessee lying adjacent thereto, the right to erect derricks and all other necessary buildings, lay pipes and powers over and across said premises, and to use water, gas and oil to drill and operate wells on this and adjacent leases; also the right to remove at any time any property placed thereon by lessee.
