RIGHT OF WAY AGREEMENT.

For and in consideration of the sum of Thirteen (\$13) dollars to him in hand paid by The Oklahoma Natural Gas Company the receipt of which is hereby acknowledged J.H. Land curator for Toady Stanwaltie do hereby grant to the said Oklahoma Natural Cas Company, a corporation, its successors or assigns, the right of way to lay, meintain, operate, relay and remove a pipe line for the transportation of oil or gas and erect, maintain, operate and remove telegraph or telephone lines with the right of ingress or egress to and from the same, said right of way being more fully described by plat of definite location, approved by the Secretary of the Interior on May 22nd 1909 on, over, and through certain lands allotted to Stanwaitie, deceased, a citizen of the Creek Nation, Roll No. 5384, situate in the County of Tulsa and State of Oklahoma, and described as fol lows:

North half of Murth west quarter Section 22 Township 18 N. Range 12 E.

The said grantors, their heirs, or assigns are to fully use and enjoy the said premises except the easement for the purposes hereinbefore granted to the said Oklahoma Natural Gas Company, its successors and assigns.

The said Oklahoma Natural Cas Company for itself and its successors or assigns hereby covenants to bury its lines so that the same will not interfere with the cultivation of said premises.
