Guardian's Deed.

THIS INDENTURE, made the 9th day of November A.D. 1909 by and between Frank N. Duckworth, the duly appointed, qualified and acting Guardian of Floyd C. Ballette, minor, the party of the first part, and T.S. Cochranc the party of the second part, Witnesseth:
