of the second part, his heirs, executors, administrators, successors and assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines, constructing tanks, buildings and other improvements thereon to take care of said products all that cortain tract of land situate in the county of Tulsa State of Oklahoma, described as follows, to-wit:

South half of the southwest quarter (Sh 5%) if section 11.
Township 19 N. Range 11 D. and containing 80 acres, more or less.

It is agreed that this lease shall remain in force for the term of five years from this date, and as long thereafter as oil or gas or either of them is produced therefrom by the party of the second part, his heirs, executors, administrators, successors and assigns.

In consideration of the precises the said farty of the second part, covenants and agrees.

1st. To deliver to the credit of the first party her heirs, executors, administrators, successors and assigns, free of cost, in the ripe line to which it may connect its wells the equal one cighth part of all oil produced and saved from the leased premises.

and. To pay to first part -- one hundred fifty dollars each year in advance for the gas from each well where gas only to found, while the same is being used off the premises, and the first party to have gas free of cost to heat five stoves in dwelling house on said premises during the same time

3rd. To pay to first party for gas produced from any oil well and used off the premises at the rate of fifty dollars per year for the time during which gas shall be so used, said payments to be made each three months in advance.

The party of the second part agrees to complete a well on said premises within twelve mon-from the date hereof, or pay at the rate of One (\$1.00) Dollar per acre in advance, for each additional twelve months such completion is delayed from the time above pentioned for the completion of such well until a well is completed, and it is agreed that the completion of such well shall be and operate as a full liquidation of all rent under this provision during the remainder of the term of this lease.

The party of the second part shall have the right to use gas, oil and water from well, a springs or streams produced on said land for its operation thereon, except water from wells of first party.

Then requested by first party the second party shall bury its pipo lines below plough depth on cultivated land.

No well shall be drilled neure than 200 feet to the house or burg on said premises.

Second party shall pay for damages caused by it to growing grops on said

The party of the second part shall have the right at any time to remove all machinery and fixtures placed on said premises, including the right to draw and remove casing. All payments which may fall due under this lease may be made direct to lessor or deposited to her credit in Central National Bank, Tulsa, Oklahoma.
