remain unpaid for the period of six months, then the aforesaid principal sum of six "undred Dollars with all arrearages thereon, and all penalties, taxes and insurance premiums, shall, at the option of suid mortgagee, or of its suc-

cessors or assigns, become payable immediately thereafter, although the period herein and by said note and said by laws limited for the payment thereof shall not then have expired, anything hereinbefore contained to the contrary thereof in anywise notwithstanding. In the event of legal proceedings to foreclose this mortgage, the indebtedness thereby secured shall bear interest from the filing of such foreclosure proceedings at the rate of ten per cent per annua in lieu of the payment of further monthly installments.
