ASSIGNMENT OF ^{an} OIL AND GAS LEASE.

WHEREAS, the Secretary of the Interior, has heretofore approved an oil and gas mining lease, dated November 14th, 1905, entered into by and between Marcus L. Lockwood, of Independence, Kansas, lessee, and William Walker, of Turley, Oklahoma, lessor, covering the following described land in the Cherokee Nation, Oklahoma.

Lots One (1) and Two (2) in Section Eighteen (18) Township Twenty one (21) North; range Thirteen (13) East, which said lease was by said lessee, under date September 20th, 1909, assigned to The Hominy Oil and Gas Company,
