tion of the sum of One Hundred and sixty (\$160.00) dollars to him in hand well and truly paid by the said party of the second part, the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of the said party of the second part, to be raid, kept and performed has granted and conveyed and by these presents does grant and convey unto the said party of the second part, his successors or assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines, and of building tanks, stations and structures thereon to take care of the said products, all that certain tract of land, situate in Julsa county, Oklahoma, to-wit:

Northeast Quarter (NE 1/4) of the Southeast Quarter (SE 1/4) of section ixteen (16) and the East Half (E 1/2) of the Southeast Quarter (SW 1/4) of the Southeast Quarter (SW 1/4) of the Southeast Quarter (SE 1/4) and the West Half (W 1/2) of the Southeast quarter (SE 1/4) of section Sine (9) all in township Kineteen (19) N. Range Ten (10) East, containing One Hundred and Sixty (150) acres, more or less.

It is agreed that this grant shall romain in force for the term of five years from this date, and as long thereafter as oil or gas, ode either of them, is produced therefrom by the party of the second part, his successors or assigns, not to exceed however the minority of said minor.

part covenants and agrees. 1st--To deliver to the credit of the first part, his heirs or assigns free of cost, in the pipe line to which he may connect his wells, or in tanks at the wells, or pay the market crics therefor, in each, the equal one eighth part of all oil produced and saved from these premises; And 2nd-- To pay One mundred fifty (\$150.00) dollars per year for the gas from each and every gas well drilled on said premises; the product from which is marketed and used off the premises, said rayments to be made on each well within sixty days after commencing to use the gas therefrom, as aforesaid, and to be maid yearly thereafter while the gas from said well is so used.

Second party covenants and agrees to locate all wells so as to interfere as little as possible with the cultivated portions of the premises.

is drilled for oil or gas within one year from the data hereof, all rights and obligations secured under this grant and demise shall cease upon three months notice in writing being served by the party of the first part, unless the earty of the second part shall elect from year to pear to continue this grant and demise in force as to any or all portions of the premises by paying in advance an annual rental of one dollar per acre for all of said lands or such portion thereof as the party of the second part may designate, until a well is drilled, provided that, upon the completion of said well, the above provided for rentals shall cease.
