

that said sale was fairly conducted and said lease executed in conformity to the orders of this court; that the consideration for said lease is fair, reasonable and adequate, and that no better or greater consideration can be obtained for said lease, and that the terms, covenants and agreements in said lease are fair, reasonable and such as will fully protect said minor and her said estate.

It is therefore by the court considered, ordered, adjudged and decreed that the return and report of sale and execution of said lease and the proceedings of said guardian, be and the same are hereby in all things approved and confirmed, and that the lease so executed by said guardian to Gardner Steel be, and the same is hereby approved and confirmed and the guardian is hereby ordered and directed to deliver said lease to the lessee therein named.
