## ORDER APPROVING LEASE.

And Now on this 6th day of January, 1910, coming on to be heard the petition of P.E. Heckman, guardian of the above named minor, for the approval of an oil and gas mining lease covering the allotment of said minor executed to E.R. Kemp, and John F. Hayden, of Tulsa, Oklahoma, and the Court having fully examined said lease, and finding that the same has been executed in compliance with the order of this court, is of the opinion that the same should be granted.
