If at any time, the Secretary of the Interior, after due notice to the persons or parties interested, determines that any person, partnership or corporation has by means of stock ownership or otherwise, directly or indirectly obtained and holds interests in leases of oil and gas properties in said Territory covering in the aggregate, an area of more than 4,800 acres, and further finds that the property herein leases is a part of said aggregate area then the Secretary of the Interior may cancel this lease in the same manner as provided for in the case of any violation of the terms of said lease.

It is further agreed and understood that the approval of this lease shall be of no force or effect, unless the party of the second part furnishes within sixty days from the date of approval of the application filed in connection herewith, a bond to the satisfaction of the Secretary of the Interior, in accordance with the regulations of March 20, 1905, prescribed by the secretary of the Interior, which shall be deposited and remain on file in the Indian Office during the life of this lease.

It is understood and agreed by the parties to this unstrument that the conditions mentioned herein shall be and they are hereby modified so that the party of the second part shall. In which obligation to commence therfirst; well upon the above described tract of land within thirty days from the date of the approval of this lease by the "ecretary of the Interior and to complete three wells upon said property within five months, from such approval.
