ORDER APPROVING LEASE+

On this day came on to be heard the petition of Andy Prince as guardian of the minors, Rosella and Hattie Lewis, requesting the approval of an oil and gas mining lease executed by him as guardian of Rosella Lewis, in accordance with an order of this court, heretofore made on this 12th day of February, 1910, and the court being fully advised in the premises, finds;

That the allotment of the said minor, Rosella Lewis, is situated in Tulsa County, State of Oklahoma, and in the Creek Nation, and described as follows; South east quarter of Southeast quarter and Northeast quarter of Southeast quarter, and West Half of Southeast quarter of Section 20, Township 19 North Range 10 east, containing 160 acres of land; that the said guardian in behalf of his minor executed an oil and gas mining lease upon the land hereinabove described to S.D. Felt of Chelsea, Oklahoma, for a term of eleven years, or as long thereafter as oil or gas may be found in paying quantities, not to exceed the minority of said minor, that there was paid as bonus for the execution of said lease which said lease was executed on February 12, 1910, the sum of Eighty Dollars; that the consideration paid is reasonable, and that the approval of said lease will be ~~conductive~~ to the best interests of the minor, and that S.D. Felt, to whom said lease is executed made the highest and best offer that was made for an oil and gas mining lease upon the said described land.

Therefore, it is by this court ordered, adjudged and decreed, that said oil and gas mining lease executed by Andy Prince Guardian of Rosella Lewis to S.D. Felt, on the 12th day of February 1910, be, and the same is hereby in every respect approved and confirmed.
