WAIVER OF OBLIGATION UNDER BOND.

DO HER BY SUBSTITUTE for the United States Indian Agent, Union Agency, Muskogee, Oklahoma, the Bank of Commerce, of Tulsa Oklahoma, as a place of payment of the rentals and royalties under this lease and do hereby authorize the lessee and his assigns to pay all rentals and royalties falling due under said lease at the said Bank of Commerce of Tulsa, Oklahoma, to the owner of the said land.
