ASSIGNMENT OF OIL AND GAS LEASE.

KNOW ALL MEN BY THESE PRESENTS:

For value received, the undersigned Miland Oil Company, a corporation, does hereby and by these presents, sell, assign, convey and transfer unto Flora McCariston of Hartford City, Indiana, an undivided three fourths interest in, to and under a certain oil and gas mining lease hereinafter described, and unto Carl Grastorf, of Bartlesville, Oklahoma, an undivided one fourth interest therein and thereunder, together with all its privileges, franchises and rights, which it now owns and holds as lessee to-wit: One certain oil and gas lease, dated November 24, 1906, made, signed, acknowledged, and delivered by John H. Wheatley, as legal guardian of Claud E. Wheatley, a minor, lessor, to Miland Oil Company, a Delaware Corporation, of Bartlesville, then Indian Territory, lessee, which lease was made as a Department lease, and was approved by the Secretary of the Interior on April 15, 1907, but which lease was taken out of the jurisdiction and control of the Department of the Interior July 25, 1909, and is recorded in the office of the Register of Deeds of Tulsa county, Oklahoma, in record 50, at page 576, and which lease covers the East half of South west quarter of section Twenty eight, Township twenty one, Range Thirteen, in Tulsa county Oklahoma. Also, all buildings, machinery, tools and fixtures used on or about said lease in operating and developing the same.

And said Miland Oil Company further assigns and transfers to said Flora McCariston and Carl Grastorf all of its right, title and interest in and to a certain agreement, made and entered into on the 10th day of November, 1910 between it and said John H. Wheatly, guardian of Claud E. Wheatley, a minor, which contract provided that for and in consideration of the completion of two wells on said lease within one year from the date hereof, the royalty provided for in said lease shall be reduced from sixteen and two thirds per cent of the gross proceeds of the oil produced to twelve and one half per cent thereof, which agreement has been approved and confirmed by the county Court of Tulsa county, Oklahoma.

In witness whereof, the said Miland Oil Company has caused this instrument to be executed by its duly authorized officers on the 14 day of November 1910.
