

RELEASE OF OIL AND GAS MINING LEASE.

KNOW ALL MEN BY THESE PRESENTS, that whereas, heretofore, to-wit on the 20th day of January A.D. 1906, S.L. Young, as guardian of Katie Webber, did make, execute, acknowledge and deliver unto John C. Smith of Independence, Kansas, a certain oil and gas mining lease on the South Half ($\frac{1}{2}$) of the Southwest Quarter ($\frac{1}{4}$) of Section Thirty three (33) Township Twenty one (21) North Range Thirteen (13) East, now Tulsa County, Oklahoma, said lease being executed on the regular department forms and duly approved by the Secretary of the Interior of the United States of America on November 6th 1906, and said lease being duly filed for record with the register of Deeds of Tulsa County, Oklahoma, on February 18th, 1910, and recorded in record 78, Page 162, of records of said office of Register of Deeds, and after execution of said lease, said lease being duly assigned to the Buckeye Oil and Gas Company, a corporation, said assignment being duly approved by the Secretary of the Interior; and,

Whereas Charles W. Grimes and O.M. Lancaster are now the owners of said land described in said lease and the royalty interest in and to said lease; and,

whereas, it is the desire of the Buckeye Oil and Gas Company, a corporation, to release all its right, title and interest in and to said lease herein mentioned and described to the said Charles W. Grimes and O.M. Lancaster, and,

Whereas it is the desire of the said Charles W. Grimes and O.M. Lancaster to again lease said land herein described and also other lands to Lydia Oil Company a corporation, for oil and gas mining purposes;

now, therefore, the Buckeye Oil and Gas Company, a corporation, in consideration of One dollar (\$1.00) cash in hand to it paid by the said Charles W. Grimes and O.M. Lancaster, the receipt whereof is hereby acknowledged, and for the further consideration that the said Charles W. Grimes and O.M. Lancaster shall again execute a lease on said land herein described to the Lydia Oil Company under different terms and conditions than those expressed in lease herein mentioned and described, hereby releases, remises, quit claims and relinquishes all its right, title and interest in and to the above described oil and gas mining lease now held by it on the South Half ($\frac{1}{2}$) of the Southwest Quarter ($\frac{1}{4}$) of section Thirty three (33) Township Twenty one (21) North, range Thirteen (13) East, Tulsa County, Oklahoma, to Charles W. Grimes and O.M. Lancaster.
