

RELEASE OF OIL AND GAS MINING LEASE.

KNOW ALL MEN BY THESE PRESENTS, That whereas, heretofore, to-wit on the 22nd day of September, 1906, Eliza Reece (nee Burr) did make, execute, acknowledge and deliver to the Lydia Oil Company, a corporation, a certain oil and gas mining lease on the North $\frac{1}{2}$ of the Southwest $\frac{1}{4}$ of Section 33, Township 21 North, Range 13 East, now Tulsa County, Oklahoma, containing 80 acres, more or less, said lease being filed for record in the office of the United States Clerk and Ex-Officio Recorder at Tulsa, Indian Territory, on February 6th, 1907; and,

Whereas, the said Eliza Reece (nee Burr) did execute, acknowledge and deliver a certain oil and gas mining lease on December 22nd, 1906, to the Lydia Oil Company, a Corporation, on the West $\frac{1}{2}$ of the Southwest $\frac{1}{4}$ of Section 33, Township 21 North Range 13 East, now Tulsa County, Oklahoma, and,

Whereas, the said lease was duly approved by the Honorable Secretary of the Interior on May 7th, 1907, said lease being filed for record on March 17th, 1908, at 8 A.M. and recorded in Book 6, Page 381 in the office of the Register of Deeds in and for Tulsa County, Oklahoma; and/

Whereas, Charles W. Grimes and O. M. Lancaster are now the owners of said land described in said leases, and the royalty interest in and to said leases; and,

Whereas, it is the desire of the Lydia Oil Company, a corporation, to release all its right, title and interest in and to said leases herein mentioned and described, to the said Charles W. Grimes, and O.M. Lancaster; and,

Whereas it is the desire of the said Charles W. Grimes and O.M. Lancaster to again lease said land herein described and also other lands to the said Lydia Oil Company, a Corporation, for oil and gas purposes:

Now Therefore, the Lydia Oil Company a Corporation, in consideration of One Dollar (\$1.00) cash in hand to it paid by the said Charles W. Grimes and O.M. Lancaster, the receipt whereof is hereby acknowledged, and for the further consideration that the said Charles W. Grimes and O.M. Lancaster shall again lease said land herein described to the Lydia Oil Company, under different terms and conditions than those expressed in the two leases herein mentioned, does hereby release, remise, quit claim and relinquish all its right, title and interest in and to the above described two oil and gas mining leases now held by it on the North $\frac{1}{2}$ of the Southwest $\frac{1}{4}$ of Section 33, Township 21 North, Range 13 East, Tulsa County, Oklahoma, to Charles W. Grimes and O.M. Lancaster.
