Now therefore, in consideration of the full payment of said promissory note, and of one dollar the receipt whereof is hereby acknowledged, the said Williams, Coss & Hogan and Allen G. Coss as Trustee, do hereby remise, release and forever quit claim unto the said Nathaniel Skidmore and his heirs and assigns forever all the right,
