PROPOSED AMENDMENT to Section 5, of Sub division "Devenue and Taxation", of Article 11 of the Charter of the City of Tulsa, authorizing and empowering the City of Tulsa to annually, by ordinance levy and collect a poll tax in the city of Tulsa, Oklahoma.

Said amendment is as follows:

Section 5 of sub-division "Revenue and Taxation" of Article 11 of the Charter of the City of Tulsa, is hereby sme nded to read as follows:

The city of Tulsa shall have power to levy and collect a poll tax on all electors of the City of Tulsa, under sixty years of age, not exceeding two dollars per capita, per annum, The said poll tax shall be levied and collected by the persons or spafed and in the manner and at the time officers hereinafter provided by ordinance of the city of Tulsa; and a penalty for non-payment of such tax when due, may be prescribed by ordinance duly enacted by the City of Tulsa.
