KNOW ALL MEN BY THESE PRESENTS, That The Uncle Sam Oil Company, a corporation organized and existing under the laws of Arizona, for value received, promise to pay to bearer, on the first day of August, in the year one thousand nine hundred and twenty five at the office of The Kansas Trust Company, in the City of Kansas City, or if this bond be registered, then to the registered holder thereof \_\_\_\_\_ dollars in lawful money of the United States of America, with interest thereon from August first, one thousand nine hundred and ten, at the rate of seven per cent per annum, such interest being payable at said office semi-annually, on the first days of February and August in each year, but only upon surrender and cancellation of the respective coupons for such interest, hereto annexed.

This bond is one of a series of bonds, all of like date, numbered consecutively from one to four thousand two hundred and fifty, both inclusive, issued and aggregating the principal sum of Three Hundred Thousand dollars, under and in pursuance of, and all equally secured, without priority or preference, by a mortgage or deed of trust, dated the first day of August, one thousand nine hundred and ten, executed by The Uncle Sam Oil Company to The Kansas Trust Company, a corporation of the State of Kansas, as trustee, recorded in the office of the register of deeds of Wyandotte County, Kansas, and of the various other counties of Kansas and Oklahoma in which the property covered by said mortgage is situated, conveying to said The Kansas Trust Company, in trust, certain real estate, with all of the buildings and improvements situated thereon and appurtenances thereto, and certain pipe lines owned by said The Uncle Sam Oil Company to which mortgage or deed of trust, reference is hereby made for a description of the property mortgaged and pledged, and the rights of the holders of this bond; *This bond may be paid by the Uncle Sam Oil Company at any interest paying period upon ten days previous notice of the intention to pay being filed with the Kansas Trust Company.* This bond may be registered as to principal, in the owner's name on the books of The Uncle Sam Oil Company, at the office of The Kansas Trust Company in the City of Kansas City, Kansas, such registry being noted on the bonds by the registrar of the Uncle Sam Oil Company, after which no transfer shall be valid unless made on The Uncle Sam Oil Company's books, by the registered owner, and similarly noted on the bond; but the same may be discharged from registry by being transferred to bearer, and thereupon transferability by delivery shall be restored, and again from time to time, it may be registered or transferred to bearer as before; such registration, however, shall not affect the negotiability of the coupons hereto annexed, which shall continue to be payable to bearer, and transferable by delivery, and payment of the coupons shall fully discharge The Uncle Sam Oil Company, in respect to the interest therein mentioned; but, at the time of, or after registration of the bond as aforesaid, the coupons may be surrendered and cancelled and such surrender and cancellation noted by such registrar upon the bond, and thereafter this bond shall permanently remain a registered bond as to interest, as well as principal, and the interest thereon semi-
