

TWENTY FIFTH: No Recourse under or upon any of the bonds issued and to be issued as herein provided or any coupon attached thereto or under or upon and obligation thereof or of this indenture or upon any right, remedy or judgment in any way resulting therefrom, shall be <sup>have</sup> ~~be~~ individually against any incorporator: stockholder or director of the Oil Company or of any successor corporation directly or through any receiver or assigns thereof by virtue of any contractual or statutory indebtedness or liability to the Oil Company or to any of the said bondholders, whether under any present or future law or otherwise, and all individual liabilities on the part of such incorporators, stockholders, directors and officers is hereby expressly waived as a condition of and as a consideration for the execution and delivery of this indenture and the issue of such bonds and coupons.

This deed of trust is subject to the lien of that certain mortgage given by The Uncle Sam Oil Company to W.T. Kemper, and recorded in the office of the register of Deeds of Wyandotte County, Kansas, covering the tract of land on which is situated the Kansas City, Kansas, refinery, to secure part payment of the purchase money on said tract.
