1910, also made and executed a certain agreement with said lessees whereby it was agreed by and between the parties thereto in what manner the consideration for said lease should be paid; that the consideration for said lease is a fair andreasonable one and as good as can be obtained; that the royalty and rental provided in said lease are fair andreasonable and as good as conhe obtained, and that it would be for the best interests of said minor if the said lease and said agreement be approved.

Wherefor, it is by the court, considered, ordered, adjudged and decreed that the seid lease and said agreement and the action of said Guardian inhaking and executing said lease and agreement, for and on behalf of said minor, be and the same are hereby approved, ratified, confirmed and declared valid, and the said Guardian is hereby directed to deliver said lease and agreement to said leasees.
