The court further finds that the said minor has not sufficient income for her maintenance and education.

And it further appearing to the court that the guardian herein has made his return of the sale of an oil and gas lease under and by virtue of an order issuing out of this court on the 26 day of November 1910; and that he has in all ways followed said order of sale, and that he has sold, executed and delivered an oil and gas lease on the above described property to Thomas White for a cash bonus of Fifty dollars and one eighth of the oil produced, and a stipulated roysity for gas.

And it appearing to the court that this lease is for the best interest and benefit of said minor in that it will tend to pay for the maintenance and Education of said minor.

New, therefore, it is by this court considered, ordered, adjudged and decreed that that certain oil and gas mining lease executed and delivered by Thomas Maken, as guardian of Rosaline Maken, a minor, to Thomas White, of date the lat day of December 1910, X is in all its terms, covenants, agreements and conditions ratified, confirmed approved anddeclared valid.
