Adair, their certain warrant deed, conveying to said W.C. Adair, all of their right, title and interest in and to the above described land; which said deed was delivered to said W.C. Adair

The court further finds that the consideration of three hundred & ten dollars ^{described} dollars, for the above land aforesaid, is adequate, and that three hundred & ten dollars has been paid by said W.C. Adair, to said grantors.

It is therefore, here now, by the court considered, ordered, adjudged and decreed that the deed as presented herewith be and the same is hereby approved according to Section 9 of an act of Congress approved May 27th, 1908, entitled an act for the Removal of Restrictions from part of the lands of the allottees of the Five Civilized Tribes; and for other purposes (Public No. 140)
