ORDER CONFIRMING AND APPROVING GUARDIAN'S LEASE OF PART OF
WARD'S LAND FOR AGRICULTURAL PURPOSES

Now on this the 5th day of December, 1908, Levi Childers, guardian herein, presents for confirmation and approval an agricultural lease upon a part of the lands of his ward, Bettie Depriest, lying in the county of Tulsa, State of Oklahoma, and more particularly described as follows, to-wit:

The west half of the South east quarter of Section twenty four (24) Township Seventeen (17) North, and Range thirteen (13) East of the Indian Base and Meridian, containing eighty acres;
for a period extending from the first day of January, 1909 to the first day of January, 1913, and said lease being executed in triplicate and Wallace M. Bentley being the lessee.

And the court having examined said lease and heard evidence upon the same, and it appearing that said lease is in proper form and does not exceed the minor's minority, and is in conformity to the order of court heretofore made, and the court being well and sufficiently advised in the premises;

It is ordered that said lease, be and the same is hereby ratified, approved and confirmed; and that a certified copy of this order be attached to each of the three parts of said contract here and now presented for approval, and that one part thereof with such certified copy attached be returned to said guardian, Levi Childers, one part with the certified copy attached be delivered to the lessee, Wallace M. Bentley; the triplicate part to remain on file in this court with the papers in the case.
