RIGHT OF WAY GRANT.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned Of K. Rysenbach, (hereinafter styled Grantor) in consideration of Sixteen & No/100 dollars in hand paid by The Texas Company, (herein styled Grantee) its successors and assigns, the right to construct, operate, and maintain a pipe line for the transportation of oil gas or water over through and upon a certain tract of land situated in the county of Tulsa, State of Oklahoma, and described as follows: TE. 1/2 of E 1/2 of SW 1/4 & W 1/2 of W 1/2 of the SE 1/4 Sec 26, Twp. 19 N. R. 12 E.

There is also hereby granted the right to erect and maintain upon and across said premises a line of poles and telegraph and telephone wires thereon, and also the right to lay adjacent to and parallel with the first pipe line a second pipe line, and the Grantee, its successors and assigns, shall at all reasonable times have the right of ingress and egress to and from said line or lines for the purposes of construction, inspecting, repairing and maintaining the same and the removal of such at will in whole or in part.
