ORDER CONFIRMING SALE OF REAL ESTATE.

Now, on this the loth day of November, 1910, there coming on for hearing the return of sale made by Jim Ceasar, as the guardian of the person and estate of Herbert Owens, a minor, said return of sale being filed herein on the 26th day of October, 1910, and said Jim Ceasar appearing in person and by attorney, and the said Mary Celia Sauls the original bidder, appearing by attorney, and the court having examined said return and haing heard and considered the evidence of witnesses offered in support of said return, and being duly advised in the premises, finds that due and legal notice was given of the hearing on said return of sale filed herein prior to this date, and that notices were duly posted according to the statute and the order of this court, for ten days in Muskogee and Tulsa Counties, State of Oklahoma, and that all parties and persons have had due and lawful notice of hearing on said return, due proof of said posting of said notices being filed on this the 19th day of November 1910.
