WITNESSETH: That the party of the first part for and in consideration of the sum of One dollar (\$1.00) in hand paid, the receipt of which is hereby acknowledged, and the further consideration that second party agrees to pay annually the sum of Two Hundred dollars (\$200.00) per year, payable in advance, from September 12, 1910, for the privilege of retaining gas producing privileges upon the NW\$\frac{1}{2}\$ of Sec. 3, T. 19 N.
