at private sale to J. Truman Nixon of Tulsa, State of Oklahoma, on the following terms, to-wit: cash bonus of \$1.00 per acre, smounting to \$160.00 royalty of 1/8% of all crude oil marketed afrom said premises, \$300.00 per annum for each gas well from which gas is utilized, and all costs of said sale including the attorney's fee.
