with the buildings and improvements thereon, for agricultural purposes.

- 3. That the lessor covenants to place the lessees in the quiet and peaceable possession of said premises on or before the beginning of the term covered by this lease, and to protect the lessees in the quiet and peaceable possession of said premises during the ther of this lease.
- 4. That the lessees promise and agree to pay to the lesser, as rental for said premises for said term the sum of Forty dollars, payable as follows: Cash in advance the lessees also buys the house and all fencies and other improvements on the above described land for the sum of Sixty dollars cash paid the receipt of which is here by acknowledged.
- 5. That no part of said rent money shall be due or payable until the lessees shall have been placed in the quiet and actual possession of said premises.
- 6. That at any time dureing this lease the lessees may move or cause to be moved, the house fencies and other improvements from the above described lands.
