DEED OF ASSIGNMENT.

THIS CONTRACT AND AGREEMENT made and entered into this, the 13th day of December, 1910, by and between Thomas White and J.K. Ronne, parties of the first part, and Gypsy Oil Company, a corporation under the laws of Oklahoma, party of the second part does

WITNESS That, For and in consideration of the sum of Sixteen Hundred Seventy two & No/ (\$1672.00) to the parties of the first part in hand this day paid by the party of the second part, the receipt whereof is hereby acknowledged, the parties of the first part have this day, granted, bargained, sold, transferred and assigned and, by these presents doeth hereby grant, bargain, sell, convey, transfer and assign to the party of the second part, its successors and assigns, (oil and gas mining leases and the leasehold estates thereby created, as follows:

Oil and gas mining lease dated January 17, 1910, between William F. Keys, lessor, and J.K. Ronne, lessee, covering the northwest quarter of south east quarter of northwest quarter; and south half of south west quarter of northwest quarter (NW/4 of SE/4 of NW/4;
