AGREEMENT.

This contract and agreement, made and entered into the 15th day of December, 1910, by and between J.W. Register and his wife, parties of the first part and Charles Page, party of the second part;

WITNESSETH: That for and in consideration of the sum of Two Thousand Five Hundred (\$2500) dollars, the receipt of One Hundred (\$100) dollars of which is hereby acknowledged, and a balance of Twenty four Hundred (\$2400) Dollars to be paid to party of the first part on completion of good title to the following land,

The North half of Northeast Quarter (N $\frac{1}{2}$ NE $\frac{1}{4}$) Section Eleven (11) Township Nineteen North (19) Range Eleven East (11E), being a part of the allotment of Sunday Scott.

It is further agreed that the parties of the first part will execute a Warranty Deed to the above described land and place same in escrow in the Central National Bank, Tulsa, Oklahoma, to be delivered to party of the second part upon payment of balance of purchase price, of Twenty Four Hundred (\$2400) dollars.

ORDER FOR REMOVAL OF RESTRICTIONS

DEPARTMENT OF THE INTERIOR? Washington D.C. Jun 9, 1909 190--
Number 3166
Roll Number 26515, Full blood

Whereas, Luther O. Greenfeather an allottee of the Cherokee Nation, has made application for the removal of restrictions from the following described land, to-wit:

The South Twenty (S20) acres of Lot One (1); and the North Half (N2) of the Southeast Quarter (SE4) of the Northeast Quarter (NE4) and the Southwest Quarter (SW4) of the Southeast Quarter (SE4) of the Northeast Quarter (NE4) all in section One (1) Township Twenty two (22) north, Range Twelve (12) East of the Indian Base and Meridian, containing 50 acres.

Now therefore, I, under the authority vested in me by the act of Congress approved May 27, 1908, (Public No. 140) and the regulations prescribed thereunder, hereby remove the restrictions from said above described land, such removal of restrictions to become effective only and simultaneously with the execution of deed by said allottee to the purchaser after said land has been sold in compliance with the directions of the Secretary of the Interior.
