FIVE YEAR RENTAL CONTRACT.

Sapulpa, Oklahoma, November 5th, 1910.

This contract and agreement, made and entered into by and between Tom Cosar, father and Jennie Cosar, mother, of Sapulpa, Oklahoma, parties of the first part, and J.M. Houston, of Jenks, Oklahoma, party of the second part:

WITNESSETH: That the said parties of the first part for and in consideration of the sum of twenty five cents per acre and the improvements hereinafter mentioned to be placed upon the premises herein described the parties of the first part hereby rents unto the second party the East Half of the Northeast Quarter of Section Thirty six (36) Township eighteen (16) North, range Twelve (12) East, of the Creek Nation, Oklahoma, and being a part of the allotment of Beeker Cosar, daughter of the first parties, for the period of five years from the date hereof, expiring on the 5th day of Movember 1915.

It is further agreed that the said second party shall pay unto the first parties the sum of twenty dollars (\$20.00) on thedate hereof the receipt of which is hereby acknowledged, to apply on the first year's rents.

The said second party agreet to enclose the whole of said lands with a good three wire fence, posts at not to exceed sixteen feet apart, and to be made during the first two years; also to break out and place in a good state of cultivation twenty five acres or more during the first and second years, and to make such other and further improvements upon said lands as the said second party may deem necessary and proper for his use and convenience during the term of this contract.
