The Atchison, Topeka and Santa Te Railway Company, a corporation, Plaintiff, Vs The Cherokee Nation, Defendant. AWARD OF REFEREES. TO THE CLERK OF THE UNITED STATES COURT FOR THE INDIAN TERRITORY, NORTHERN JUDICIAL

DISTRICT.

We, the undersigned, heretofore appoint ed by the Judge of the above entitled court, To appraise the compensation and damages to be paid to the above named defendant by reason of the appropriation and condemnation of the land sought to be condemned by the plaintiff in this action for station grounds, side tracks, wye tracks, and other railroad purposes, which lands are described as follows, to-wit: All the land in section Thirty (30) and thirty one (31) in Township Twenty one (21) North, of range fourteen (14) east of the Indian Meridian in said Indian Territory, lying easterly of a line fifty (50) feet normally distant from, easterly of, and parallel to, the located center of The Kansas, Oklahoma Central and Southwestern Railway, and westerly of a line one hundred fifty (150) feet normally distant from, easterly of and parallel to, said located center line. The northerly boundary of said land being a line at right angles to paid located center line through location station 2076 plus 50 feet of said located center line, and the southerly boundary & line to said located center line through location station 2106 of said located center line; also the land in said sections thirty (30) and Thirty one (31) lying westerly of a line fifty (50) fest normally distant from, westerly of, and parallel to said located center line and easterly of a line one hundred fifty (150) feet normally distant from, westerly of and parallel to said located center line. The northerly boundary of said land being a line at right digles to said loated center line through location station 2076 plus 50 feet of said located center line and the southerly boundary a line radial to said located center line through location station 2106 of said located center line. The two above described parcels containing in all thirteen and fifty seven hundredths (13.5?) acres.
