WHEREAS, a townsite commission, heretofore appointed under the Act of Congress approved May 31, 1900 931 Stats 221) and acting under authority of theAct of Congress approved July 1, 1902, (32 Stats 716) ratified by the Cherokee Nation August 7, 1902, has appraised the lots in the town of Owasso, Okla, formerly Cherokee Nation, Indian Territory; and

Whereas, the plat of said town was approved by the secretary of the Interior on the 26th day of March 1904, and was duly flaced on file; and Whereas, said commission has appraised all of the town lots included in said plat at their true value, excluding improvements, which appraisal has been approved by the Secretary of the Interior, and

WHEREAS, the said commission has awarded the real estate described hereinbelow to Abraham Carlin who has paid seventy dollars, the full amount of the purchase prefice into the treasury of the United States, to the credit of the Cherokee Nation of Indians with the United States Indian Agent at Muskoges, Indian Territory, and is, therefore entitled to a patent:
