We, the undersigned, heretofore appointed by the Honorable Joseph A. Gill, Judge of the United States Court for the Indian Territory, Northern District, to appraise the compensation and damages to be paid to the above named defendants and to all persons interested by reason of the appropriation and condemnation of lands sought to be appropriated in the above entitled proceeding by The Atchison, Topeka and Santa Fe Railway Company as successor in interest by Judicial sale of The Kansas Oklahoma Central and Southwestern Railway company for right of way and other railroad purposes on the line of its amended definite location, between Owasso in the Cherokee Nation and Tulsa in the Creek Nation in said Indian Territory, respectfully report that before entering upon the duties of our appointment we each took and subscribed before a competent authority an oath that we would faithfully and impartially discharge the duties of our appointment, which oaths duly certified are returned herewith. That before proceeding to the appraisement of compensation and damages to be paid by reason of the appropriation of the lands hereinafter described, we caused ten days personal
