

## TRACT NUMBER 5.

All that part of the south half (1/2) of the southwest quarter (1/4) of section twenty (20) Township Twenty (20) north range thirteen (13) east in the Cherokee Nation Indian Territory lying within Fifty (50) feet on each side of the center line of the main track of The Atchison, Topeka and Santa Fe Railway company as the survey therefor is now located over and across said section twenty (20) containing two and 13/100 (2.13) acres more or less.

We further find that the Cherokee Nation is the owner of said land and that A. W. Twist is the owner of the improvements on said land and that said A.W. Twist has selected said south half (1/2) of the <sup>south</sup> northwest quarter (1/4) of section twenty (20) as his allotment as a citizen of the Cherokee Nation subsequent to the filing and approval of the Railway Company's maps of amended definite location, and that the right of way hereby condemned and appropriated has been deducted from the allotment of said A.W. Twist.

We further find that the Cherokee Nation or Tribe of Indians is therefore entitled to the value of the land taken, to-wit: the sum of \$14.91; and that said A.W. Twist is entitled to the value of the improvements taken and to the damages to the remainder of said land, to-wit: the sum of \$40.00; and that no other person or persons have any interest in said land or in or to the award hereby made.

## TRACT NUMBER 6.

All that part of the north half (1/2) of the northwest quarter (1/4) of section twenty nine (29) township twenty (20) north range thirteen (13) east in the Cherokee Nation Indian Territory lying within fifty (50) feet on each side of the center line of the main track of The Atchison Topeka and Santa Fe Railway <sup>Company</sup> as the survey therefor is now located over and across said northwest quarter (1/4) section between profile stations 2527 plus 44.4 and 2530 and all of said north half (1/2) of said northwest quarter (1/4) of said section twenty nine (29) lying within fifty (50) feet on the westerly side and withing seventy five (75) feet on the easterly side of said located centerline, between profile station 2530 and the south line of said north half (1/2) of the northwest quarter (1/4) of said section twenty nine (29) containing 5 and 46/100 (5.46) acres more or less.

## TRACT NUMBER 7

All that part of the north half (1/2) of the southeast quarter (1/4) of section thirty (30) township twenty (20) north range thirteen (13) east in the Cherokee Nation Indian Territory lying within fifty (50) feet on each side of the center line of the main track of the Atchison Topeka and Santa Fe Railway <sup>Company</sup> as the survey therefor is now located over and across said southeast quarter (1/4) section between profile stations 2567 plus 24.2 and profile station 2572 and all lying within seventy five (75) feet on each side of said located center line between profile stations 2572 and 2580 and all lying within one hundred (100) feet on each side of said located
