Tulsa, Indian Territory, January 2, 1905.

In consideration of the sum of fifty (50) dollars to me in hand paid by The
Atchison Topeka and Santa Fe Railway Company the receipt whereof is hereby acknowledged
I hereby acknowledge full settlement and satisfaction of all claims for damages,
which have accrued or which may hereafter accrue by reason of the said Railway Company
taking possession of, removing improvements from, and constructing and maintaining a
railroad on its right of way as now surveyed over and across the following described lands,
held and occupied by me as tenant or lessee thereof;

All that part *of the* southeast quarter (1/4) of the northeast quarter (1/4)
of section fourteen (14) township twenty (20) north, range thirteen (13) east, lying
within fifty (50) feet on each side of the center line of said Railway Company's main
track as now located across said southeast quarter (1/4) of said northeast quarter (1/4)
section containing two and 32/100 acres more or less.

Also all that part of the east half of the southeast quarter (1/4) of said sec-
tion fourteen (14) lying within 75 feet on each side of said center line, containing
three and 11/100 acres more or less, being part of the allotment of Wancy Wright,

Also all that part of the west half of the southeast quarter (1/4) of said
section fourteen (14) lying within 75 feet on each side of said center line, containing
five and 96/100 acres more or less, being part of the allotment of Effie I. Hardman, all said
land being in the Cherokee Nation, Indian Territory.

And in consideration of the payment of the above sum of money, I hereby remise,
release and relinquish all my right and title in and to the right of way above described
and to the improvements thereon and to all claims for damage to any part of the above
described tracts of land, owned or held by me by virtue of any leases from the owners
or allottees of said land or by virtue of any other rights or contracts whatever.

I further agree to hold said Railway company harmless from all claims of
sub tenants or sub lessees of any part of the above described lands which they may have
on account of the location and construction of a railroad over and across the same and
permission is hereby given to said Railway company to at once enter upon said right of
way and commence the construction of its said railroad across the same.

I reserve the right to remove all improvements on said right of way, said im-
