## DEED OF ASSIGNMENT.

WITNESS That, For and in consideration of the sum of Four Hundred and fifty (\$450.00) Dollars to the party of the first part in hand this day paid by the party of the second part, the receipt whereof is hereby acknowledged, the party of the first part has this day granted, bargained, sold, conveyed, transferred, assigned, and set over to, and by these presents doth hereby grant, bargain, sell, convey assign, transfer and set over to the Gypsy Oil Company, its successors and assigns, his certain oil and gas mining lease on, and leasehold estae in and to the following described land to-wit:
