line, and the grantee its successors and assigns, shall at all teasonable times have the right of ingress and egress to and from said line or lines for the purposes of construction, reairing and maintaining the same and the removal of such at will in whole or in part.

The Grantee, its successors and assigns, to select the route of such lines.

To have and to hold the said easements unto the said The Texas Company, its successors and assigns, so long as such structures are maintained.

By acceptance hereof, the grantee covenants for itself, successors and assigns, that it will so bury said pipe lines as that such will not interfere with the cultivation of the premises, and also that it will pay all demages to crops and fences which p may be suffered from the maintaining and operating of said pipe lines.

It is understood that the person securing this right of way in behalf of the grantee is without authority to make any covenant or agreement in respect to the premises not expressed herein.
