

Order Confirming Sale of Real Estate

State of Oklahoma

In the Matter of the estate of Charley Cowans, a minor,

NOW, On this 8th day of July, 1911, there coming on for hearing the return of sale made by James H. Kennedy as the Guardian of the estate of Charley Cowans a minor and said James H. Kennedy appearing (A) in person and by his attorney, W. T. Drake and no person or persons appearing to protest said said confirmation, and notice of this hearing having been given for ten days, by posting notice thereof in three of the most public places in Wagoner County, Oklahoma, as required by law and as per order of this Court, and the Court having examined said return, and having heard and considered the evidence of witnesses offered in support of said return of sale

and being fully advised in the premises, finds:

That in pursuance of said order of sale, said James H. Kennedy on the 26th day of June, 1911, sold the portion of the real estate of said estate described as follows, to-wit:

The East Half of the North-East Quarter of Section 13, Township 19 North, Range 10 East, Tulsa County, Oklahoma,

at Public sale to T. C. Harrill upon the following terms, to-wit

For the sum of \$212.00 payable as follows:

All cash upon confirmation of said sale by the County Court of Wagoner County, Oklahoma.

That said sale was made after due notice as prescribed by said order of sale; that said purchaser was the highest bidder therefor, and said sum the highest and best sum bid; that said sale was legally made and fairly conducted; that said sum is not disproportionate to the value of the property sold, and that a sum exceeding such bid at least ten (10) per cent. exclusive of the expense of a new sale cannot be obtained, and that the said James H. Kennedy in all things proceeded and conducted and managed such sale as required by the statute in such case made and provided, and as by said order of sale required and directed.

It is therefore ordered, adjudged and decreed by the Court, that the said sale be, and the same is hereby confirmed and approved and declared valid, and the said James H. Kennedy is directed to execute to said purchaser proper and legal conveyance of said real estate.
