DEED OF GENERAL WARRANTY.

# This indenture, Made on the 15th day of January, 1910, by and between Jim Ceasar as the duly appointed, qualified, and acting guardian of the estate of Lizzie McIntosh a minor, of Muskogee County, State of Oklahoma the party of the first part, and John Kennemer, the party of the second part,

Witnesseth, That whereas, on the 12th day of November, 1909, the County Court of Muskogee County, , State of Oklahoma made and entered an order of sale authorizing the said party of the first part to sell certain real estate of the gaid Lizzie McIntosh a minor, situate in the County of Tulsa, State of Oklahoma, and particularly described in said order of sale and described herein, which said order is now on file and of record in the said County Court of Muskogee County, State of Oklahoma in a case pending in said Court and styled in the matter of the estate of Lizzie McIntosh et al. minors, and said order is hereby referred to for greater certainty;

And whereas, under and by virtue of said order of sale and pursuant to legal notices given thereof, the said party of the first part, on the 8th day of December, 1909, at the time and place and in the manner specified in said notices, did offer for sale and sell, subject to confirmation by said Court, to the party of the second part, the said real estate hereinafter particularly described for the sum of \$1600.00, he best being the highest and best sum bid;
