ASSIGNMENT OF MORTGAGE/

KNOW ALL MEN BY THESE PRESENTS: That Mary E. Green of Seattle, Washington for and in consideration of the sum of ten (10) Dollars lawful money of the United States, to her in hand paid by Mary Green Fiske, of the same place the receipt of whereof is hereby acknowledged, have granted, bargained, sold, assigned, transferred, and set over, and by these presents do grant, bargain, sell, assign, transfer and set over unto the said Mary Green Fiske and to her heirs and assigns, that certain Indenture of Mortgage bearing date the 22nd day of November in the year of our Lord one thousand nine hundred and nine and executed by C. A. Sanderson & Wife Elizabeth Sanderson as parties of the first part thereto, to Mary E. Green as party of the second part thereto, mortgaging the following described tract or parcel of land, lying and being in the County of Tulsa and State of Oklahoma and particularly bounded and described as follows, to-wit:

All of Lot No. nine (9) in block No. Six (6) of the Buena Vesta Addition to the town of Tulsa Oklahoma according to the amended and recorded plat thereof.

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging to secure payment of the sum of fifteen hundred (1500) Dollars, gold coin of the United States, together with interest thereon in like gold coin, at the rate of 8 per cent per annum from Nov. 22/ 1909 until paid, according to the terms and conditions of two certain promissory notes, bearing date November 22nd 1909, made by said C. A. Sanderson & Elizabeth Sanders payable to the order of Mary E. Green.

And I also hereby sell assign, transfer and set over unto Mary Green Fiske said promissory notes, secured by said mortgage, and the money due and to grow due thereon.

Said mortgage above described was filed for record in the office of the Register of Deeds, of Tulsa County, Oklahoma on the 26th day of November 1909 and recorded in in Record 61 of Mortgages, on page 290, records of said County.
